<u>Qualifying criteria for interested contractor/bidder :</u>

- 1. Registered with Govt./Semi Govt. Departments/Autonomous Bodies in appropriate class
- 2. Minimum Annual Turn over from Construction works during last 3 consecutive years shall not be less than **5.26 lakhs.**
- 3. Should have **completed** satisfactorily similar works/civil construction works of (i) *one work* of value not less than **6.28 Lakh** *against single work order* **OR** (ii) two works of value not less than **3.92 Lakh** each against *two separate work orders* **OR** (iii) three works of value not less than **3.14 Lakh** each against *three separate work orders* during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by work order and completion certificate.
- 4. Complete Tender document must be uploaded with scanned copies of qualifying documents as per the qualifying criteria as stated in serial no.1,2 and 3 above along with PAN and GST . Tenderers will be required to upload the scanned copies of the **Demand Draft** against tender fee (non-refundable) and Earnest Money (EMD) drawn in favour of the Registrar, Tezpur University payable at Tezpur. Tezpur University reserves the right to accept or reject any or all the tender document without assigning any reason thereof . The original Tender Fee and EMD should be submitted or reach the Registrar, TU before the bid opening date.
